CCCSH POLICY ISSUES TRACKING 2021-2022

Tracking table of California state legislation, the California Coalition for Children's Safety and Health (CCCSH) is actively working on or tracking. This current tracking table is for the 2021-2022 two-year legislative session. Occasionally in partnership with our national safety and health partners we will include national regulatory actions or Congressional bills.

CCCSH is a 30-year-old non-profit organization, and since 1991 has provided an important statewide coalition setting allowing for collaborative work to be carried out by organizations, agencies and individuals interested in advancing safety and health for all California children and youth through age 19 years old. An example of some of the accomplishments of CCCSH's collaborative partnerships and advocacy leadership work produced: A bicycle helmet law covering all children up through age 18; established California's Kids Plates specialized vehicle license plate law to help provide base funding for child abuse prevention, child care health and safety, and unintentional injury prevention; Crib Safety Act; Playground Safety Regulations; Child passenger safety and shoulder harness laws; supported the establishment of and current efforts to advance teen driver safety, Graduated Driver License program; Pool Safety Act; the current eight year old CA Unintentional Injury Prevention Strategic Plan Project; to name a few examples.

With limited funding and resources, CCCSH's work is heavily reliant on input from our Board of representatives from across the state and issue experts, and especially CCCSH's leadership and lead staffs' extensive legislative knowledge and their largely volunteer work to advance the policy work CCCSH's leadership and Board identifies as appropriate and priority issues to engage in. CCCSH's legislative agenda and advocacy leans on the partnerships and networking of likeminded coalitions, organizations, agencies, and individuals. We cannot do this alone. The majority of CCCSH's work is focused on supporting state and local coalition development, building partnerships, gathering data and research on the issues we are focused on, and coordinating advocacy to advance safety and health collaboratively, including teaching and mentoring new advocates in the art of policy advocacy. Though CCCSH is primarily focused on safety and

health issues, with unintentional injury prevention as a priority, CCCSH does lend its advocacy resources to important issue areas that also advance safety and health for all California children, youth, and their families.

This tracking table purpose is to provide a summary "bird's eye view" of policy issues we are currently engaged in, what role CCCSH has and how CCCSH's leadership and partners are involved, the status of the policy issue, next steps, and contact for more information. Though CCCSH and its partners are in a leadership position on a policy issue, does not mean we always have unanimous agreement on the issue details, but expect CCCSH's partners and leaders to work together collaboratively, openly, and without personal or organizational attacks because there are disagreements. CCCSH works primarily by consensus but has a majority vote Charter provision if it is necessary to allow CCCSH to move forward even if there are dissenters to the majority position.
